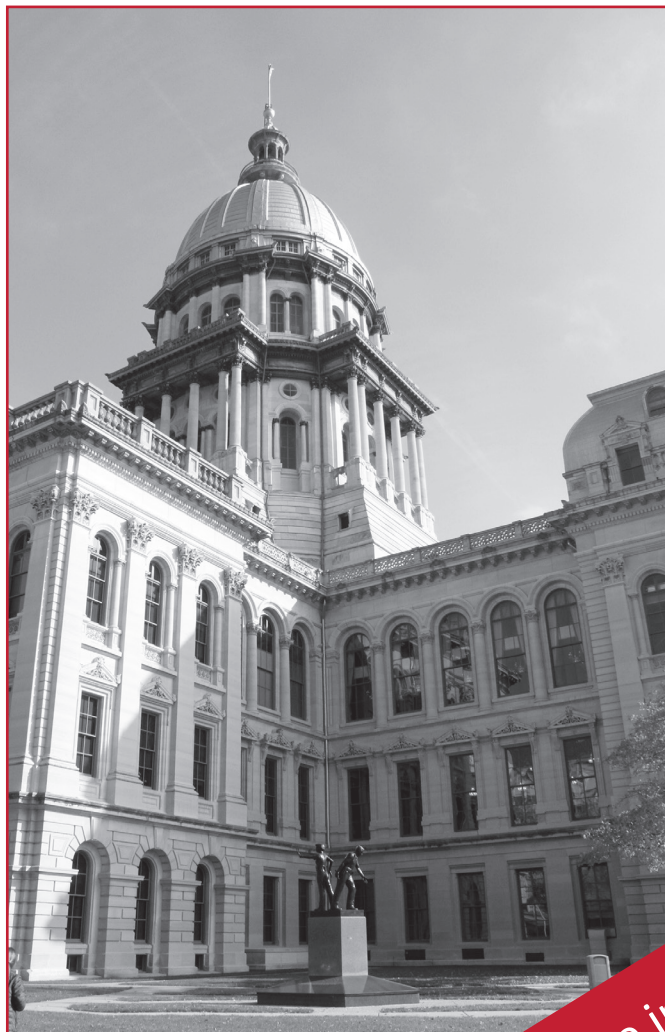

2018 Voter Guide | U.S. Congressional Candidate Survey Questions

Federal candidates were asked if they Support or Oppose:

- 1 | H.R. 3762 – repeals key pillars of the Patient Protection and Affordable Care Act and, for one year, would defund Planned Parenthood.
- 2 | H.Amdt. 1062 to H.R. 4974 – Allows Veterans Affairs medical professionals to recommend marijuana as medicine.
- 3 | H.R. 3185 (2015) – Equality Act adds “sexual orientation” and “gender identity” to many federal laws, granting special privileges based on behavior.
- 4 | H.Amdt. 1130 to H.R. 5055 – Prevent federal funds from being used to undermine religious freedom protections in the Religious Freedom Restoration Act.
- 5 | H.Amdt. 1244 to H.R. 5485 – Prohibit funds from being used by Selective Services to register women for the Draft.
- 6 | H.R. 4828 – would permanently prevent government discrimination against pro-life entities and allow for civil action.
- 7 | H.R. 3219 – Make America Secure Appropriations Act would fund many security-related expenses and give the U.S. control over those entering and exiting the country by constructing a border wall.
- 8 | H.R. 781 – Free Speech Fairness Act would eliminate the Johnson Amendment’s prohibition on political speech by tax-exempt organizations.
- 9 | H.R. 490 – Heartbeat Protection Act of 2017 would ban abortion when the baby’s heartbeat is able to be detected, except in the case when the life of the mother is in jeopardy.
- 10 | H.R. 1 – Tax Cuts and Jobs Act would reduce individual and business income tax rates.
- 11 | H.J.Res. 121 – Parental Rights Amendment secures the rights of parents to direct the upbringing and care of their children.
- 12 | Amdt. 183 to H.R. 2810 – bans taxpayer funded sex reassignment surgery for members of the military.

National Democratic & Republican Party Platforms | 5 Issues

Abortion/Life

Democratic Platform on | Securing Reproductive Health, Rights, and Justice

We believe unequivocally, like the majority of Americans, that every woman should have access to quality reproductive health care services, including safe and legal abortion—regardless of where she lives, how much money she makes, or how she is insured. We believe that reproductive health is core to women’s, men’s, and young people’s health and wellbeing. We will continue to stand up to Republican efforts to defund Planned Parenthood health centers, which provide critical health services to millions of people. We will continue to oppose—and seek to overturn—federal and state laws and policies that impede a woman’s access to abortion, including by repealing the Hyde Amendment. We condemn and will combat any acts of violence, harassment, and intimidation of reproductive health providers, patients, and staff. (p33)

Republican Platform on | The Fifth Amendment: Protecting Human Life

The Constitution’s guarantee that no one can “be deprived of life, liberty or property” deliberately echoes the Declaration of Independence’s proclamation that “all” are “endowed by their Creator” with the inalienable right to life. Accordingly, we assert the sanctity of human life and affirm that the unborn child has a fundamental right to life which cannot be infringed. We support a human life amendment to the Constitution and legislation to make clear that the Fourteenth Amendment’s protections apply to children before birth. (p13)

We oppose the use of public funds to perform or promote abortion or to fund organizations, like Planned Parenthood, so long as they provide or refer for elective abortions or sell fetal body parts rather than provide healthcare. (p13) ... We oppose the non-consensual withholding or withdrawal of care or treatment, including food and water, ... just as we oppose euthanasia and assisted suicide. (p13)

We applaud the U.S. House of Representatives for leading the effort to add enforcement to the Born-Alive Infant Protection Act by passing the Born-Alive Abortion Survivors Protection Act, which imposes appropriate civil and criminal penalties on healthcare providers who fail to provide treatment and care to an infant who survives an abortion, including early induction delivery whether the death of the infant is intended. We strongly oppose infanticide. ... (p14)

We call on Congress to ban sex-selection abortions and abortions based on disabilities — discrimination in its most lethal form. We oppose embryonic stem cell research. (p14)

Marriage/Family

Democratic Platform on | Guaranteeing Lesbian, Gay, Bisexual, and Transgender Rights

Democrats applaud last year’s decision by the Supreme Court that recognized that LGBT people—like other Americans—have the right to marry the person they love. But there is still much work to be done. LGBT kids continue to be bullied at school, restaurants can refuse to serve transgender people, and same-sex couples are at risk of being evicted from their homes. That is unacceptable and

must change. Democrats will fight for the continued development of sex discrimination law to cover LGBT people. We will also fight for comprehensive federal non-discrimination protections for all LGBT Americans, to guarantee equal rights in areas such as housing, employment, public accommodations, credit, jury service, education, and federal funding. We will oppose all state efforts to discriminate against LGBT individuals, including legislation that restricts the right to access public spaces. We support a progressive vision of religious freedom that respects pluralism and rejects the misuse of religion to discriminate. We will combat LGBT youth homelessness and improve school climates. We will support LGBT elders, ensure access to necessary health care, and protect LGBT people from violence—including ending the crisis of violence against transgender Americans. We will also promote LGBT human rights and ensure America’s foreign policy is inclusive of LGBT people around the world. (p17)

Republican Platform on | Marriage, Family and Society

[The American family] is the foundation of civil society, and the cornerstone of the family is natural marriage, the union of one man and one woman. ... Strong families, depending upon God and one another, advance the cause of liberty by lessening the need for government in their daily lives. (p31)

Children raised in a two-parent household tend to be physically and emotionally healthier, more likely to do well in school, less likely to use drugs and alcohol, engage in crime or become pregnant outside of marriage. We oppose policies and laws that create a financial incentive for or encourage cohabitation. Moreover, marriage remains the greatest antidote to child poverty. The 40 percent of children who now are born outside of marriage are five times more likely to live in poverty than youngsters born and raised by a mother and father in the home. Nearly three-quarters of the \$450 billion government annually spends on welfare goes to single-parent households. This is what it takes for a governmental village to raise a child, and the village is doing a tragically poor job of it. (p31)

The data and the facts lead to an inescapable conclusion: Every child deserves a married mom and dad. ... We honor the courageous efforts of those who bear the burdens of parenting alone and embrace the principle that all Americans should be treated with dignity and respect. But respect is not enough. Our laws and our government’s regulations should recognize marriage as the union of one man and one woman and actively promote married family life as the basis of a stable and prosperous needs and strengths of the family. (p31)

Immigration

Democratic Platform on | Fixing our Broken Immigration System

We will support efforts by states to make DREAMers eligible for driver’s licenses and in-state college tuition. We will invest in culturally-appropriate immigrant integration services, expand access to English language education, and promote naturalization to help the millions of people who are eligible for citizenship take that last step. (p15)

We will work to ensure that all Americans— regardless of immigration status—have access to quality health care. That means expanding community health centers, allowing all families to buy into the

Affordable Care Act exchanges, supporting states that open up their public health insurance programs to all persons, and finally enacting comprehensive immigration reform. (p16)

Republican Platform on | Immigration and the Rule of Law

Our immigration system must protect American working families and their wages, for citizens and legal immigrants alike, in a way that will improve the economy. ... (p25)

America's immigration policy must serve the national interest of the United States, and the interests of American workers must be protected over the claims of foreign nationals seeking the same jobs. ... We oppose any form of amnesty for those who, by breaking the law, have disadvantaged those who have obeyed it. (p25)

That is why we support building a wall along our southern border and protecting all ports of entry. ... We insist upon workplace enforcement of verification systems so that more jobs can be available to all legal workers. Use of the E-verify program — an internet-based system that verifies the employment authorization and identity of employees — must be made mandatory nationwide. We reaffirm our endorsement of the SAVE program — Systematic Alien Verification for Entitlements — to ensure that public funds are not given to persons not legally present in this country. We demand tough penalties against those who engage in identity theft, deal in fraudulent documents, and traffic in human beings. ... (p26)

Because “sanctuary cities” violate federal law and endanger their own citizens, they should not be eligible for federal funding. Using state licenses to reward people in the country illegally is an affront to the rule of law and must be halted. (p26)

Judiciary

Democratic Platform on | Appointing Judges

We will appoint judges who defend the constitutional principles of liberty and equality for all, and will protect a woman's right to safe and legal abortion, curb billionaires' influence over elections because they understand that Citizens United has fundamentally damaged our democracy, and believe the Constitution protects not only the powerful, but also the disadvantaged and powerless. (p23)

Republican Platform on | The Judiciary

We condemn attempts by activist judges at any level of government to seize the power of the purse from the people's elected representatives by ordering higher taxes. (p2) ...

A critical threat to our country's constitutional order is an activist judiciary that usurps powers properly reserved to the people through other branches of government. (p10)

We support the appointment of judges who respect traditional family values and the sanctity of innocent human life. (p13)

In Obergefell, five unelected lawyers robbed 320 million Americans of their legitimate constitutional authority to define marriage as the union of one man and one woman. The Court twisted the meaning of

the Fourteenth Amendment beyond recognition. To echo Scalia, we dissent. We, therefore, support the appointment of justices and judges who respect the constitutional limits on their power and respect the authority of the states to decide such fundamental social questions. (p11)

Religious Liberty

Democratic Platform on | Respecting Faith and Service

Democrats know that our nation, our communities, and our lives are made vastly stronger and richer by faith in many forms and the countless acts of justice, mercy, and tolerance it inspires. We believe in lifting up and valuing the good work of people of faith and religious organizations and finding ways to support that work where possible.

We believe in the power of national service to solve problems and break down barriers by bringing people of all backgrounds together in common purpose. National service expands opportunity for people across America, strengthening our communities and our country. And those who serve earn education awards that they can use for college while building valuable work skills. We will support and strengthen AmeriCorps with the goal that every American who wants to participate in full-time national service will have the opportunity to do so. (p17)

Democratic Platform on | Religious Minorities

We are horrified by ISIS' genocide and sexual enslavement of Christians and Yezidis and crimes against humanity against Muslims and others in the Middle East. We will do everything we can to protect religious minorities and the fundamental right of freedom of religion. (p41)

Republican Platform on | The First Amendment: Religious Liberty

The Bill of Rights lists religious liberty, with its rights of conscience, as the first freedom to be protected. Religious freedom in the Bill of Rights protects the right of the people to practice their faith in their everyday lives. As George Washington taught, “religion and morality are indispensable supports” to a free society. Similarly, Thomas Jefferson declared that “No provision in our Constitution ought to be dearer to man than that which protects the rights of conscience against the enterprises of the civil authority.” ...

We pledge to defend the religious beliefs and rights of conscience of all Americans and to safeguard religious institutions against government control. (p11) ■

- A | HB 217 (2015) banned counseling for minors who suffer from unwanted same-sex attraction and gender dysphoria.
- B | SB 1564 (2015) required medical professionals to give referrals and information on medical procedures they find morally objectionable (i.e. abortion).
- C | HB 40 (2016) allows tax dollars to pay for abortions through Medicaid and state employees' insurance plans.
- D | HB 1785 (2016) allows individuals who suffer from gender dysphoria to change their gender and name on a birth certificate.
- E | SB 2228 (2016) reduced penalties of possession of 10 grams of cannabis to a civil law violation and fine of \$100-\$200.
- F | HB 2353 House Amendment 1 (2017) legalizes recreational marijuana for adult use.
- G | SB 9 (2017) increased personal income tax and corporate tax by over 30%.
- H | SB 31 (2017) creates sanctuary jurisdictions in all state-funded schools and day-care centers; state-funded medical treatment and health care facilities, nursing homes, group homes for persons with developmental disabilities, community-integrated living arrangements, and state mental health facilities; facilities operated by the Office of the Secretary of State; and circuit courts, State appellate courts, and the Supreme Court.
- I | SB 7 (2017) doubles the number of casinos, increases electronic gambling, expands number of positions at existing casinos from 1,200 to 1,600, and grants a perpetual casino license for Chicago with 4,000 positions.
- J | Do you support or oppose physician-assisted suicide?
- K | Do you support or oppose defunding Planned Parenthood?
- L | Do you support or oppose ratification of the Equal Rights Amendment (ERA), which would eliminate gender distinctions in over 800 federal laws?
